Devon, the points I will communicate in person are as follows:

- 1. YT has provided tainted, incorrect information to further her own agenda. I have other concrete examples of this.

- 4. AMU will play an important and constructive role in Ukraine's recovery. I will detail minister and BHL involvement, and soon some US involvement.
- 5. The guy is a kingmaker in his country and will continue to be despite YT's efforts.
- 6. The only ask is that an introductory meeting be arranged in Vienna between some designee of the USG and DF. This could then lead to closer communication from him about his intentions and direction in his country.
