- Types of Events
  - Social discourse events casual environment where people can discuss topics like health care or criminal justice
  - Speaker events individuals with unique views or relevant topics
  - Ad-hoc meetings
- Budget
  - O Social discourse events will be hosted at restaurants
  - o Biggest expense will be speakers
- Working to promote stronger community within longer
- Working to enhance the academic environment within school
- Arguing that they do not share an overlapping missing with already existing student orgs
- Open to working with other organizations
- Plan for self-generating funding
  - Speaker and dinner

- Why does this require an SBA charter to talk? Demetrius W.
  - Believe it falls under an area of law that people study and practice
  - Believe people don't bring up ideas because of a stigma, believe we should talk about this and give them a place
- Why cannot fall under another organization? Demetrius W.
  - Could go under Fed Soc and create task force? D.W.
  - Answer is that their values are not necessary aligned with groups like Fed Soc
- O Is this Emory Law or Emory Uni organization? Mason M.
  - Emory Uni
  - Because of limited funding, how would this work?
  - They would like to be inclusive
- Will you bring controversial speakers? Mason M.
  - Not trying to bring individuals who will be divisive
  - There are concerns about the speakers

  - Not for the group meetings, they are just trying to talk...
