Thanks again for all the work in getting the public announcement of the Board out the door. I've gotten a lot of positive notes today, which are always nice to read.



Hi all: Sarah is offline for a bit. Here is the information our press team has been providing to reporter inquiries on background. This is the fact sheet that we prepared.

On background, attributable to a DHS spokesperson:

DHS Launches Disinformation Governance Board to Coordinate Counter-Disinformation Activities

Disinformation poses significant and increasing risks to homeland security, including by fueling terrorism and targeted violence. The spread of disinformation can affect border security, Americans' safety during disasters, and public trust in our democratic institutions.

Recognizing this elevated threat and the need to ensure that we are leveraging our resources efficiently and responsibly, DHS created the Disinformation Governance Board (DGB) to coordinate activities related to countering disinformation with a homeland security nexus. Through the DGB, DHS will ensure that its efforts to address disinformation with a homeland security nexus are conducted in ways that protect privacy, civil rights, and civil liberties. The DGB will also ensure that DHS is efficiently leveraging all available resources and capabilities to mitigate and counter disinformation with a homeland security nexus, consistent with its authorities and applicable laws.

The DGB's immediate areas of focus are as follows:

- Irregular migration: The DGB is supporting DHS's work to counter disinformation spread by human smugglers that prey on vulnerable populations attempting to migrate to the United States. These smugglers, many of whom are part of transnational criminal organizations, make a profit by spreading false information that endangers lives.
- Russia: In February 2022, President Biden designated DHS to stand up a Unified Coordination Group (UCG) to ensure a unified federal response to domestic preparedness efforts related to the current Russia-Ukraine crisis. The DGB is supporting the UCG's efforts to monitor and prepare for potential disinformation threats to U.S. critical infrastructure.

In tandem with these efforts, the DGB is reviewing the Department's internal capabilities, resources, authorities, and programming, as well as streamlining and enhancing related relationships within other federal agencies, the private sector, and research community.

The DGB is led by Executive Director Nina Jankowicz, and co-chaired by Under Secretary for Policy Rob Silvers and Acting Principal Deputy General Counsel Jen Daskal. The Board is composed of leaders from the Departments' Cybersecurity and Infrastructure Security Agency (CISA), Federal Emergency Management Agency (FEMA), U.S. Customs and Border Protection (CBP), Office of Intelligence and Analysis (I&A), Science and Technology Directorate (S&T), Privacy Office (PRIV), and the Office for Civil Rights and Civil Liberties (CRCL), Office of the General Counsel, and Office of Strategy, Policy, and Plans.
