The Interior Ministry confirmed that Zlochevskiy is no longer wanted

An adviser to the Minister of Internal Affairs, Zorian Shkiryak, confirmed that the former Minister of Ecology and Natural Resources Mykola Zlochevskiy is no longer wanted. He stated this on the TV channel "112 Ukraine".

"Yes, in fact, today it has been implemented. MIA performed a technical function, as was the decision of the GPU. As procedural heads they have provided a package of documents. In this situation, we have fulfilled the judgment, which was sent to the head of the procedure, that is, the Department of the GPU disclosure of economic crimes ", - he said.

Along with this, Shkiryak expressed the hope that all the officials of Yanukovych regime will be justly punished. "I can only say that Zlochevskiy was involved to commit large-scale crimes against the State of Ukraine", - he said.

Earlier it was reported that in the register of wanted persons MIA vanished card with information about Zlochevskiy wanted . What gave reason to believe that the agency withdrew from the investigation of former officials.

As reported, the Kyiv Pechersk District Court ordered the GPU to remove from tracing the ex-Minister of Ecology and Natural Resources Mykola Zlochevsky .

Recall that in January last year, GPU announced in tracing Ecology Zlochevskiy ex-minister , who was arrested accounts of \$23 million.

July 7 Prosecutor General of Ukraine Yuriy Lutsenko told about the disclosure of the gas train, which was carried out by "Esko-North" and which involved the former Minister of Environment Nicholas Zlochevskiy.

A week later, the Pechersk district court of Kyiv satisfied the petition of the Prosecutor General of Ukraine (GPU) and seized the accounts Burisma group of companies owned by the former Minister of Ecology and Natural Resources Mykola Zlochevskiy.
