Dear Secretary Mayorkas:

During the 118th Congress, the Committee on Oversight and Accountability (Committee) has conducted a government-wide investigation of how federal agencies are addressing the infiltration and influence campaign to weaken and corrupt the United States undertaken by the Chinese Communist Party (CCP). This infiltration and influence tactic is one facet of a larger cold war the CCP utilizes in its unrestricted warfare against America, which the CCP considers its "main enemy." During its briefings with over twenty federal agencies in its investigation,

the Committee has learned of the emphasis the CCP has placed on influencing subnational government leaders, including state governors.<sup>2</sup> Along those lines, the Committee has recently received whistleblower disclosures informing the Committee of serious concern among Department of Homeland Security (DHS) personnel regarding a longstanding connection between the CCP and Minnesota Governor Timothy James Walz. Specifically, through whistleblower disclosures, the Committee has learned of a non-classified, Microsoft Teams group chat among DHS employees—titled "NST NFT Bi-Weekly Sync"—that contains information about Governor Walz that is relevant to the Committee's investigation. The Committee has also learned that further relevant information regarding Governor Walz has been memorialized in both classified and unclassified documents in the control of DHS. The attached subpoena requires DHS to produce these documents and communications regarding Governor Walz's connections with the CCP; this subpoena is issued pursuant to Rule XI.2(m)(1)(B) of the Rules of the House of Representatives and Rule 12(g) of the Committee's rules.

The Committee's investigation of the CCP—begun long before Governor Walz was elevated to be the vice-presidential candidate for Democratic presidential candidate Kamala Harris—seeks to understand the extent of the CCP's infiltration and influence campaign and to identify legislative reforms to combat CCP political warfare targeting prominent Americans for elite capture.<sup>3</sup> In particular, if a state governor and major political party's nominee for Vice President of the United States has been a witting or unwitting participant in the CCP's efforts to weaken our nation, this would strongly suggest that there are alarming weaknesses in the federal government's effort to defend the United States from the CCP's political warfare that must be urgently addressed. Along those lines, the Committee is currently considering legislative

The information required of DHS by the Committee's subpoena will inform the Committee's understanding of how successful the CCP has been in waging political warfare in and against the United States, how effectively federal agencies are addressing the communist regime's campaign, and what reforms are necessary to counter this threat.

The Committee on Oversight and Accountability is the principal oversight committee of the House of Representatives and has broad authority to investigate "any matter" at "any time" under House Rule X.
