**COMPLAINT FOR INJUNCTIVE RELIEF**

---

Plaintiff Mark J. Block, by his attorneys Husch Blackwell LLP, and in support of his cause of action for injunctive relief arising out of violations of Wis. Stat. § 943.201(2)(a)-(b) and Wis. Stat. §§ 946.80-946.88, states and alleges as follows:

**INTRODUCTION**

Political campaigns prize the support they receive from small-dollar donors. More than just functioning as a source of funding, a high volume of individual donations suggests a valuable, vast network of people who will likely put their ballot where their money is and vote for the candidate or candidates they supported in the coming election.

For example, within a day of Vice President Harris taking over President Biden's campaign, she received \$81 million from 888,000 grassroots donors;<sup>1</sup> this total quickly swelled to

more than \$310 million by the end of the month.<sup>2</sup> Harris campaign spokesman Kevin Munoz stated that these donations represent “exactly the kind of grassroots energy and enthusiasm that wins elections.”<sup>3</sup>

Unfortunately, however, at least some of those donations—and similar donations to campaigns and organizations across the country—have been fraudulently made.

Starting in May 2024, Plaintiff’s personally identifying information (“PII”) has been fraudulently used to make over 385 donations worth over \$884 dollars to 62 campaigns and political organizations; 35 of these donations were to the Harris Victory Fund.<sup>4</sup> While these fraudulent donations average out to a very small \$3.24 per transaction, they conveniently fit into a loophole created by Federal Election Commission (FEC) reporting requirements.

Specifically, federal law does not require campaigns to itemize contributions from donors when the aggregate amount totals less than \$200. Campaigns that receive contributions below \$200 can simply bundle the donation into a list of un-itemized contributions. Small dollar donations have seen explosive growth in recent years, with the number of reported transactions increasing by 400% just between the 2016 and 2020 elections.<sup>5</sup>

Bad actors can influence elections by laundering their “smurfing” activities (*i.e.*, making contributions via the PII of numerous donors or “smurfs”) through these anonymous bulk reports. Since FEC data on small-dollar donors is organized by donor rather than campaign, someone would first have to know or suspect who a “smurf” might be before a record search would reveal a pattern of structured fraudulent donations. Unless of course that bad actor was like the John Doe in this case, and made the critical mistake of using the Plaintiff’s PII to launder fraudulent campaign contributions.

### **PARTIES**

1. Plaintiff, Mark J. Block, is an individual residing in Waukesha County, State of Wisconsin at 18125 West Plateau Lane, New Berlin, Wisconsin 53146.

2. Defendant, John Doe, is an unknown Defendant who has been using Plaintiff’s PII to make fraudulent donations to Democratic candidates and political organizations across the country.<sup>6</sup>

### **JURISDICTION AND VENUE**

3. This Court has jurisdiction over the subject matter of this dispute pursuant to Article VII § 8 of the Wisconsin Constitution, which provides for the subject matter jurisdiction over all civil matters within the State of Wisconsin.

4. Venue is proper in Waukesha County under Wis. Stat. § 801.50(2)(c) because it is the county in which Plaintiff resides.

## FACTUAL ALLEGATIONS

5. Plaintiff is a long-time Republican political strategist with extensive experience navigating the regulations that govern political fundraising.

6. Plaintiff served as chief of staff (“COS”) to Herman Cain in his 2012 campaign to become the Republican nominee for President of the United States.

7. As COS, Plaintiff occasionally used the email address caincos@gmail.com (“COS Email”) to sign up for newsletters from the political campaigns of various candidates.

8. Because political campaigns often share or sell their email lists, to track how his personal information was circulated, Plaintiff would sometimes utilize the pseudonym “Bernie Cain” and the COS Email (together, “Cain Information”) when signing up for these newsletters.

9. For example, if, after signing up for emails from “Campaign X” using the Cain Information, “Campaign Y” started sending emails to the COS Email addressed to “Bernie Cain,” Plaintiff would know those two campaigns were sharing data.

10. After the 2012 election, the COS Email was largely dormant and Plaintiff checked it infrequently.

11. Beginning in May 2024, however, an entity called ActBlue started to send receipts to the COS Email.

12. These receipts stated that political donations had been made in the name of “Bernie Cain” and referenced the COS Email.

13. Plaintiff did not make, authorize, or consent to any of these donations, nor did he consent to the use of the Cain Information to process these donations.

14. ActBlue is a Massachusetts-based limited liability company and hosts a website that serves as a central hub for contributions to candidates, organizations, and nonprofits aligned with the Democratic Party.

15. When donating to ActBlue, users confirm that they are providing accurate information, including their real name and email address.

16. They must also state that the contribution is made from their own funds.

17. Once a donation is made via ActBlue, a receipt is sent to the email provided by the user.

18. Among other items, the receipt lists:

- a. The name of the donor;
- b. The amount donated;
- c. The date of donation;
- d. The payment method; and,
- e. The campaign or organization receiving the money.

19. Between May 13, 2024, and October 7, 2024, 385 donations (“ActBlue Donations”) were made using the Cain Information. Attached and incorporated hereto as **Exhibit A** is a spreadsheet containing a chronological listing of each of the ActBlue Donations.

20. The ActBlue Donations were made to 62 political campaigns (“ActBlue Campaigns”).

21. The spreadsheet attached as **Exhibit A** details the ActBlue Campaigns, the amount each received, the number of contributions made to each recipient, and the mean and median contribution amount:

22. As shown in this attached spreadsheet, the typical donation ranged from \$1 to \$5, with only 4 over \$10.00.

23. Of these donations, 86 were initiated as one-time donations, 234 were set up as donations recurring on a weekly basis, and 65 recur on a monthly basis.

24. All ActBlue Donations were made using the same American Express card, which ends in number 4005, expires in July 2026, and tracks to the zip code 90403 located in Santa Monica, California (“AmEx Card”).

25. The donations list the donor’s address as a UPS mailbox located at 1223 Wilshire Blvd., #802, Santa Monica, CA, 90403 (“UPS Location”).

26. Plaintiff is not connected in any way with the AmEx Card and has never authorized its use to make donations through the Cain Information to any political entity, much less ActBlue.

27. Plaintiff is not connected in any way with either the UPS Location or the AmEx Card.

28. Upon investigation, Plaintiff discovered that the UPS location was used as a mailing address for a “Cain Companies Construction” (“Cain Co.”).

29. Cain Co. was administratively dissolved by the California Secretary of State in 2013.

30. California records listed the principal of Cain Co. as Bernard L. Cain, Jr.

31. Plaintiff neither knows nor has any connection with either Cain Co. or Bernard L. Cain, Jr.

32. Upon learning of the nexus between the UPS Location and the fraudulent donations made using the Cain Information, Plaintiff has made multiple efforts to contact Bernard L. Cain, Jr.



33. Plaintiff sent a package to the UPS Location that was delivered on September 12, 2024, and packages to two residences believed to be associated with Bernard L. Cain, Jr.: one in Colorado (“CO Residence”) that was delivered on September 16, and one in California (“CA Residence”) where an attempted delivery revealed that Bernard L. Cain, Jr., no longer resided there (together, “Cain Residences”).

34. Additionally, on September 19, 2024, Plaintiff sent an email to two addresses (“Cain Emails”) that are believed to relate to Bernard L. Cain, Jr.

35. In all of these messages, Plaintiff informed Bernard L. Cain, Jr., of the unauthorized use of Plaintiff’s PII and requested him to contact the undersigned counsel to discuss these fraudulent donations.

36. In what can only be interpreted as a lack of any connection between Bernard L. Cain, Jr., and these fraudulent donations, as of this filing, Plaintiff has received no response to any of these multiple overtures.

37. Furthermore, since delivery of these messages, the fraudulent donations have continued.

38. Specifically, another 151 donations have been made since September 12, 2024 (the date of the first delivery to the UPS Location), totaling \$303.40.

39. If the parties connected with the UPS Location, Cain Co., or the Cain Residences were involved in either the mistaken or fraudulent use of Plaintiff’s PII, then at the very least, it is reasonable to assume that these donations would have ceased, even if they declined Plaintiff’s invitation to discuss this activity.

40. While fraudulently making so many small-dollar donations may seem a needless waste of time, political campaigns—including as noted above Vice President Harris’ campaign—often highlight their total number of small-dollar donors and donations.

41. And for the Defendant John Doe’s purposes, fraudulent small-dollar donations exploit a loophole in federal reporting requirements.

42. Specifically, under federal law, a campaign is not required to itemize a donor’s information if the total contribution is less than \$200.00. *See, e.g.*, 52 U.S.C. § 30104.

43. Because these donations were structured to fly under the \$200 reporting requirement, *none* of the ActBlue Campaigns have reported receiving contributions from “Bernie Cain.”

44. Plaintiff has never used the Cain Information to make political donations or obfuscate federal reporting requirements.

45. Plaintiff did not make, authorize, or consent to these donations to the ActBlue Campaigns, and the Defendant’s unlawful acts could expose Plaintiff to investigation by the FEC for contributions made under a false name. *See, e.g.*, 52 U.S.C. §§ 30122, 30109.

46. Plaintiff has expended numerous hours working with counsel to prepare a filing with the FEC detailing this fraudulent activity and ensuring that he would face no exposure for any improper donations.

47. Plaintiff has never used the Cain Information in connection with any credit card.

48. Plaintiff never authorized the use of the Cain Information for political donations.

49. Plaintiff does not know the “John Doe” Defendant who made these contributions and has never given consent to third parties use the Cain Information to make political donations.

50. Given Plaintiff's political leanings, he would never consider or consent to donating to any of the ActBlue Campaigns.

**COUNT I - CIVIL ACTION FOR LOSS CAUSED BY CRIME**  
**WIS. STAT. §§ 895.446 and 943.201(2)(a)-(b)**

51. Plaintiff incorporates paragraphs 1 through 50 above.

52. When Defendant John Doe made the ActBlue Donations, Defendant acted without any authority or consent to use Plaintiff's PII.

53. Specifically, under Wisconsin law, PII includes "information that can be associated with a particular individual through one or more identifiers or other information or circumstances." Wis. Stat. § 943.201(1)(b)(15).

54. As the Cain Information is specifically associated with the Plaintiff, both the COS Email as well as the pseudonym "Bernie Cain" independently qualify as PII under Wisconsin law.

55. Pursuant to Wis. Stat. § 943.201(2)(a), it is a Class H felony to intentionally use an individual's PII without his or her consent to "obtain" a "thing of value or benefit." (Henceforth, the "Fraudulent Benefit" provision.)

56. It is also a Class H felony under Wis. Stat. § 943.201(2)(b) to fraudulently use PII "to avoid civil or criminal process or penalty." (Henceforth, the "Civil Avoidance" provision.)

57. John Doe's 385 donations to the ActBlue Campaigns violated both the Fraudulent Benefit and Civil Avoidance provisions of Wisconsin's identity theft statute.

58. Under the Fraudulent Benefit provision, John Doe utilized Plaintiff's PII to unlawfully benefit the ActBlue Campaigns; in addition to increasing the monetary donations, John Doe artificially inflated their number of small-dollar donors and small-dollar donations.

59. John Doe violated the Civil Avoidance provision by using Plaintiff's PII to mask the true identity of the donor.

60. The use of another person’s name to make a political contribution is prohibited by federal law and may be punished by fines or incarceration. *See* 52 U.S.C. §§ 30109; 30122.

61. Furthermore, Plaintiff has been forced to take steps to prevent future identity theft, including but not limited to notifying the FEC that fraudulent contributions were made through the use of Plaintiff’s PII.

62. Pursuant to Wis. Stat. § 895.446(1): “[a]ny person who suffers damage or loss by reason of intentional conduct ... that is prohibited under s. 943.201 [Wisconsin’s identity theft statute] ... has a cause of action against the person who caused the damage or loss.”

63. John Doe unlawfully used Plaintiff’s PII as part of a scheme to benefit the ActBlue Campaigns, and John Doe’s actions have injured Plaintiff by requiring him to expend time and resources to take remedial steps to cure this intentional act of identity theft.

64. Accordingly, John Doe is liable for damages and injunctive relief under Wisconsin’s statutory provisions for loss caused by crime.

**VIOLATIONS OF WISCONSIN ORGANIZED CRIME CONTROL ACT  
WIS. STAT. § 946.83(2)-(3)**

65. John Doe violated the Wisconsin Organized Crime Control Act, Wis. Stat. § 946.80-946.88 (“WOCCA”).

66. Specifically, John Doe violated two provisions of WOCCA: the “Interest Provision” found at Wis. Stat. § 946.83(2)<sup>7</sup> and the “Participation Provision” of Wis. Stat. § 946.83(3).<sup>8</sup>

67. John Doe’s activities meet the “pattern of racketeering activity” and “enterprise” requirements common to claims under the Interest Provision and Participation Provision of WOCCA.

### **RACKETEERING ACTIVITY / IDENTITY THEFT**

68. Under WOCCA, violations of Wisconsin’s identity theft statute (Wis. Stat. § 943.201) qualify as “racketeering activity.” Wis. Stat. § 946.82(4).

69. Both the Fraudulent Benefit and Civil Avoidance provisions addressed above qualify as “racketeering activity.”

70. WOCCA requires at least 3 incidents of racketeering activity to establish a “pattern of racketeering activity.” Wis. Stat. 946.82(3).<sup>9</sup>

71. John Doe well surpassed WOCCA’s minimum of 3 offenses with at least 385 incidents of identity theft.

(3) No person employed by, or associated with, any enterprise may conduct or participate, directly or indirectly, in the enterprise through a pattern of racketeering activity.

<sup>9</sup> Wis. Stat. § 946.82(3) states:

(3) “Pattern of racketeering activity” means engaging in at least 3 incidents of racketeering activity that have the same or similar intents, results, accomplices, victims or methods of commission or otherwise are interrelated by distinguishing characteristics, provided at least one of the incidents occurred after April 27, 1982 and that the last of the incidents occurred within 7 years after the first incident of racketeering activity. Acts occurring at the same time and place which may form the basis for crimes punishable under more than one statutory provision may count for only one incident of racketeering activity.

## **ENTERPRISE**

72. WOCCA's broad definition of "enterprise" includes most types of formal and informal associations, including but not limited to a partnership, a corporation, or an "association or group of individuals associated in fact although not a legal entity." Wis. Stat. § 946.82(2).<sup>10</sup>

73. Under WOCCA, the enterprise itself need not be engaged in or even aware of any unlawful activity; in fact, the "enterprise" can be a governmental entity which, by definition, is incapable of criminal liability. Wis. Stat. § 946.82(2).

74. Here, the relevant "enterprises" were ActBlue and the ActBlue Campaigns.

75. As detailed below, John Doe associated with and maintained an interest in ActBlue and the ActBlue Campaigns, in violation of WOCCA.

### **COUNT II – VIOLATION OF WOCCA - INTEREST PROVISION WIS. STAT. § 946.83(2)**

76. Plaintiff incorporates paragraphs 1 through 50 and 65 through 75 above.

77. The Interest Provision of WOCCA states:

No person, through a pattern of racketeering activity, may acquire or maintain, directly or indirectly, any interest in or control of any enterprise or real property.

78. John Doe engaged in no less than 385 acts of racketeering activity by making donations in violation of Wisconsin's identity theft statutes.

79. By contributing to and artificially inflating the number of small donors and small-dollar donations contributing to ActBlue and the ActBlue Campaigns, John Doe indirectly maintained an interest in the operation of these enterprises.

80. Because these enterprises are entirely dependent on donations that will never return a direct profit to the donors in a traditional sense, by making these fraudulent donations, John Doe clearly sought to materially benefit these enterprises.

81. Plaintiff has been injured by the unauthorized use of his PII.

82. Plaintiff has had to expend time and resources to take steps to prevent future identity theft and has been forced to notify the FEC that contributions were fraudulently made in his name.

83. Accordingly, by indirectly maintaining an interest in the operation of ActBlue and the ActBlue Campaigns through the repeated violation of Wisconsin's identity theft laws, John Doe violated the Interest Provision.

**COUNT III - VIOLATION OF WOCCA - PARTICIPATION PROVISION  
WIS. STAT. § 946.83(3)**

84. Plaintiff incorporates paragraphs 1 through 50 and 65 through 75 above.

85. The Participation Provision of WOCCA states:

No person employed by, or associated with, any enterprise may conduct or participate, directly or indirectly, in the enterprise through a pattern of racketeering activity.

86. By welcoming all donors, ActBlue and the ActBlue Campaigns allow anyone—including John Doe—to “associate” with them; accepting the invitation, John Doe participated in their operations by making fraudulent donations through Plaintiff's PII.

87. Unlike typical businesses, ActBlue and the ActBlue Campaigns are dependent on donations from the public at large, typically from donors who are in political sympathy with the

general goals of the Democratic Party and the specific agendas of the candidates running the ActBlue Campaigns.

88. With a business model dependent upon the beneficence of like-minded individuals, ActBlue and the ActBlue Campaigns therefore welcome anyone and everyone interested in funding these campaigns and advancing their agendas.

89. By making these fraudulent donations, John Doe associated with ActBlue in pursuit of a common goal: funding Democratic campaigns and organizations to advance left-leaning policies.

90. By making these fraudulent donations John Doe was clearly “associating” with these enterprises and participating in their operation.

91. Plaintiff has been injured by the unauthorized use of his PII.

92. Plaintiff has had to take steps to prevent future identity theft and has been forced to notify the FEC that contributions were fraudulently made in his name.

93. Given the distinctive method by which people “invest” in political campaigns by donating money, John Doe conducted business with ActBlue and the ActBlue Campaigns and participated in their operation by repeatedly making fraudulent donations.

### **PRAYER FOR RELIEF**

WHEREFORE, Plaintiff respectfully asks this Court to provide the following relief:

- A. Enter judgment in favor of Plaintiff on all counts of the Complaint;
- B. Awarding Plaintiff damages, including compensatory damages, double actual damages, triple exemplary damages, and punitive damages;
- C. Awarding Plaintiff the costs of suit, including reasonable attorneys’ fees and costs of investigation;



- D. Awarding pre- and post-judgment interest to the extent allowed by law; and
- E. Granting such further relief as this Court deems just and equitable.
