- We did a look at that a few months ago. It's a multi-day query because the data set is so large. It takes a large number of hours from critical people to run. Jonathan and I have talked about the data a few times and it's worth talking through before we make the request, because the data is complex and may not be very helpful
- What do we want to use it for? We might have info that can address the same question that is not that exact request

### Jocelyn:

- City council and Dingell know along with ed duggan
- We will need to make a statement shortly

#### Tina:

• Ok we will circulate what we have drafted

# Jocelyn:

 Need to be able to say the vast majority of voters reg w an ID or DL and have a number to go with that

#### Tina:

- What we can say is the % who register at branches where you have to present proof of residency which we validate
- That's in the TPs we put together for the house admin hearing

# Jocelyn:

No I need an overall number brater and I talked he knows what I need

#### Tina:

• I talked to him too. Can we hop on a call quickly

- No
- I'm on stage

#### Tina:

Ok

#### Jocelyn:

- Need to get the number and not debate this please rn
- I appreciate we are a team that loves to deliberate but we don't have time for that now
- Will need a draft statement by 1:30 please send it for me to review after I'm done speaking thx

#### Tina:

• It's not about deliberation it's about what's available

#### Jonathan Brater:

• We need to be prepared for a statement without a number. We can't get an accurate number immediately, it is a very complicated query that takes many hours minimum. I agree with Tina that raw number is not likely to be helpful

# Jocelyn:

- Thanks lmk when we have a draft reactive statement to review or if we want to issue something proactively
- Let's decide in the next 30 mins?

#### Tina:

• We are looking at number options right now, will have a statement ready for you with or without number depending on what we are able to pull together

# Jocelyn:

- Ok lmk what yall decide
- Number doesn't need to be in statement
- Dana and I talked earlier also want to weave in you're going to see significant consequences unfold for this gentleman, that should be a deterrent

#### Tina:

Got it

### Jocelyn:

- Voting records are public so we will catch you if you do this etc etc
- So isolated, rare, not widespread, happened once before in 2018. Swift and significant consequences, voting records are public if you try this you will be caught.
- Goal: communicate we are not messing around, even though this is just 1 person that is one person too many.

### Tina:

Got it

# Jocelyn:

• Put in on him as a liar and a lawbreaker not us

#### Jonathan:

· My edits are in

# Jocelyn:

- I have a 2p zoom and will look again at my email at 230
- Statement is great
- Well done
- One edit
- Say "We also take seriously our responsibility to ensure that every eligible voter is able to register and cast a ballot."
- Instead of "We also take our responsibility to ensure that every eligible voter is able to register and cast a ballot."
- Otherwise it's great
- And I would lead with

We are aware and working with the local clerk and prosecutor to address a potential violation of the law involving a non-U.S. citizen voting at an Ann Arbor early voting site on Sunday.

### Tina:

• Got it. For some reason Angela can't comment on this thread so I'm sharing her thoughts – one last edit that was suggested at the end:

Let this be a message: Voting records are public – any noncitizen who attempts to vote fraudulently in Michigan will be exposing themselves to great risk, and will be prosecuted to the fullest extent of the law.

Rational is if we say "will be caught" we could invite questions about how this was uncovered"

Good to send out?

#### Jocelyn:

- I'm good with that change and yes, good to send out
- Thanks everyone. Great work.

# Mike Brady:

• Just to confirm, is this statement to be issued proactively immediately or is it ready for reactive comment?

What do you recommend?

# Aghogho Edevbie:

At this point, I think we should be proactive. We're down to hours, possibly minutes before
there's broader awareness. With the council and Dingell knowing, it will get out. It's best if we
speak first.

#### Jonathan:

There's still a question of coordinating with other affected entities including clerk and law
enforcement. Part of the problem in the Macomb situation is the clerk did a release without
doing that.

### Jocelyn:

• Should we check in with Jackie and do a joint announcement with her?

#### Tina:

 Angela just talked to her – we are good on that end. Working to reach AG Comms and then will be good to send it out

# Jocelyn:

- Is it possible at all to do this tomorrow morning?
- It's just hard because in like two hours, I'll be taking the stage and I'd rather not have this taint that
- Have we gotten any press inquiries yet at all?
- I just spoke to Jackie and she did not know of any

#### Tina:

- We just talked to Kim, we are ready to go when we get the ok from you. I think by tomorrow it will be out and we will miss our opportunity to frame it.
- We have not gotten press inquiries yet. But a lot of people know about it.

### Jocelyn:

- Have you gotten any press inquiries yet at all? Is there value into waiting when we do because they wont publish anything before talking to us
- Is it just us making a statement or is it joint with Jackie and Dana?

### Angela Benander:

- Hi I was locked out of this thread for a bit
- They will publish something this explosive before they come to us

# Jocelyn:

Is it just us making a statement or is it joint with Jackie and Dana?

### Angela:

- It would just be you at this point
- I have spoken to both of their comms reps

### Jocelyn:

- Why don't they want to join us?
- I just spoke with Jackie and she did not seem happy about us putting out a statement

### Angela:

- We can hold but we will be reacting
- Very unlikely this doesn't hit the media today
- Bc we know people on both official and political side know

#### Jonathan:

• I think Jackie's unhappy because (1) it's drawing attention to it (2) unusual to announce before charges filed. I did her this was likely going public soon anyway which would be the reason to talk about it proactively, but that's the dilemma.

### Angela:

• 1) Debbie Dingell announced it to everyone 2) these are unusual circumstances

# Aghogho:

• I get that being proactive is not the usual course her, but we are in an extraordinary situation. This is occurring mere days before the election and if we are reactive, we'll be on the defensive and may have to explain why we waited.

### Jocelyn:

- I would like any proactive statement to be made jointly with the clerk or local prosecutor
- So let's work on developing that.
- I spoke with Eli. He and I will issue a joint statement when he's ready.

#### Jonathan:

• In other news, for awareness we did send the Rock river township supervisory control directive today. Other township officials will follow the law and Alger county govt is working with us too.

• Looks like we're sticking at 126 k, things slowed down. I don't think we'll hit 2 mill tonight unless a lot of people are working late

• We are above 2 million overall!

Jonathan:

110 k early votes today, tracking a bit lower than yesterday

 My hope is that we can say 1 million people voted early in person and so if we keep tracking over 100 every day, we'll get there

### Jonathan:

116 k

- You guys I misread this headline to mean the opposite and almost had a heart attack

### Jocelyn:

- Monday it is then
- Thx

#### Cheri:

• The Laura Coates interview has been moved to tomorrow at 8:30am. Do you still want to call in rather than zoom?

### Angela Benander:

• Good afternoon- we're putting out a release with quotes from partners on rides to the polls. Here's a draft quote for your review:

A lack of affordable or available transportation should not be a barrier to casting a ballot for any Michigan citizen. Thanks to the Michigan legislature lifting the ban on providing rides to polling for those who need them this is the first year organizations can provide this important service to voters. Thank you to these groups and companies that are going the extra mile to provide rides for voters who need it. These services will be essential for many, especially older residents and voters with disabilities, to ensure every voter can make their voice heard in this election.

# Jocelyn:

It's important that transportation not stand in the way of any eligible Michigan citizen and their
access to the ballot box. I'm glad lawmakers worked to lift the ban on providing rides to voting
locations and grateful to the organizations who have stepped up to provide transportation for
citizens who need it to vote. These services will be essential for many, especially older citizens
and voters with disabilities, to ensure every eligible voter can make their voice heard in this
election.

#### Jocelyn:

Flagging that our release that went out at 530p has old numbers in it

#### Tina Anderson:

Is there a specific one that you're concerned about?

The numbers that went out are the ones from this morning, which is the full set we use, and is comparable with what was released in 2020. The 116k number is from the end of tonight and is a one off that BOE shared (will be updated on dash tomorrow).

Our protocol is to release numbers that match the dashboard and are updated in the morning.

- We crossed 2m early this morning but dash still says 1.99
- Dash will update tomorrow with end of todays numbers

### Angela:

Correct- we put the 2020/2024 comparison out weekly

# Jocelyn:

- I announced already that we crossed 2M when we did
- So it contradicts that

### Angela:

• And use the numbers that are on the dashboard

### Tina:

• That was a mid day number, and contradicts the dashboard. The release says "as of this morning"

# Jocelyn:

• I think if we're going to do as you suggest then we should put those numbers out in the morning, not in the evening because they're not entirely accurate when we put them out in the evening

# Angela:

Year sorry we just got behind today

# Jocelyn:

• So if you wanna put a release out with numbers from the day before, let's just do it first thing in the morning as opposed to at the end of the day when the numbers are no longer accurate

# Angela:

• I think if anyone calls us on it we can say you had the up to the minute number

### Jocelyn:

- Ann Arbor put out their numbers too as end of day not beginning of day so again if we're going
  to do beginning of day, let's do it at the beginning of the day so it to not confuse people
