The defendant did:

Count 1: LEWD AND LASCIVIOUS BEHAVIOR

The above-named defendant on or about Thursday, June 5, 2025, in the Village of Mount Pleasant, Racine County, Wisconsin, did publicly and indecently expose his genitals, contrary to sec. 944.20(1)(b), 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 2: DISORDERLY CONDUCT

The above-named defendant on or about Thursday, June 5, 2025, in the Village of Mount Pleasant, Racine County, Wisconsin, while in a public or private place, did engage in violent, abusive, indecent, profane, boisterous, unreasonably loud or otherwise disorderly conduct, under circumstances in which such conduct tended to cause or provoke a disturbance, contrary to sec. 947.01(1), 939.51(3)(b) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

The official records and files of the Racine County District Attorney's Office, the Wisconsin Department of Justice and/or Department of Transportation reflect that the defendant has the following record of convictions:

The complainant, being first duly sworn on oath, on information and belief, alleges and states that in the County of Racine, State of Wisconsin, the defendant did commit the above described offense(s) and prays that said defendant be dealt with according to the laws of the State of Wisconsin.

STATE OF WISCONSIN - VS - Rohan T De Silva

The complainant states that he is an adult citizen and has reviewed the official law enforcement reports prepared under the above mentioned complaint numbers by the above stated officer, whose reports your complainant relies upon as truthful and accurate inasmuch as they were prepared during the course of an official law enforcement investigation. The complainant relies upon the statements of the mentioned witnesses inasmuch as they are citizens and their statements are based on personal knowledge or eyewitness observations; the complainant relies upon the statements of the defendant, if any, inasmuch as they are contrary to the defendant's penal interests and are, therefore, to be believed.

The complainant thereby informs the court that the basis for the above charge(s) is as follows:

On 6/5/25 at approximately 6:39 PM, the Mount Pleasant Police Department was dispatched to the Delta Hotel parking lot located at 7111 Washington Avenue, Village of Mount Pleasant, County of Racine, State of Wisconsin. The complainant, a hotel employee, advised dispatch that a man wearing a blonde wig was masturbating himself inside a red Fiat vehicle in the parking lot with the door open. Police made contact with the vehicle and identified the vehicle's operator via Wisconsin driver's license as Rohan De Silva (DOB: 11/17/1960), the registered owner.

Police spoke with De Silva, who stated, "I was touching myself, I'm really, really sorry and I'd like to go." Police observed De Silva to not be wearing pants while seating in the driver's seat and to be wearing stockings (very light see through stockings along with a female thong). De Silva was also observed to be wearing a bra, a jacket, and a blonde wig. De Silva was asked the reason for his behavior and he stated that "he was lonely and believed to be away from everyone."

Police reported that De Silva's vehicle was observed to be located close to the hotel entrance parking lot and across the street from Case High School. The Case High School parking lot was full at the time of the incident.

De Silva advised police that he was cited for indecent exposure in Illinois in August of 2024. De Silva stated that it was a similar incident, as he was also touching himself.
